

## INVITATION FOR BIDS (IFB) Petrojam Limited's Seawall Rehabilitation Works

Petrojam Limited invites contractors with suitable experience and resources to submit bids for the execution of Petrojam Limited's Seawall Rehabilitation Works at its facility located at 75-96 Marcus Garvey Drive, Kingston 15.

The scope of work includes but is not limited to:

- i. Clearing/grubbing areas surrounding existing wall structure;
- ii. Demolishing existing wall structure;
- iii. Excavating along shoreline for proposed wall and revetment;
- iv. Constructing proposed wall along shoreline;
- v. Placing revetment armor stones

### **Eligibility Criteria**

Interested bidders are required to submit the following with their bids:

1. Copy of valid Tax Compliance Letter (TCL) or valid Tax Compliance Certificate (TCC)
2. Proof of registration with the National Contracts Commission in the category of "**Building Construction Grade 1**"
3. Bid Security of Six Hundred Thousand Jamaican Dollars (J\$600,000.00) in the form of a Bank Guarantee, Bid Bond or Manager's Cheque.
